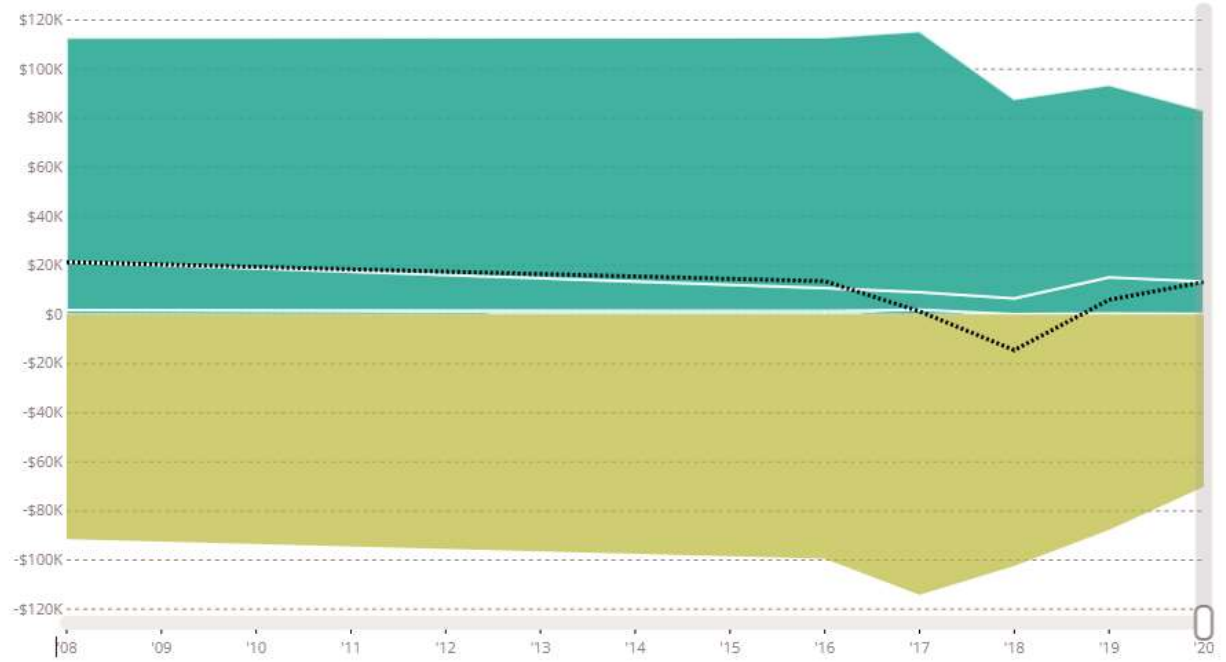

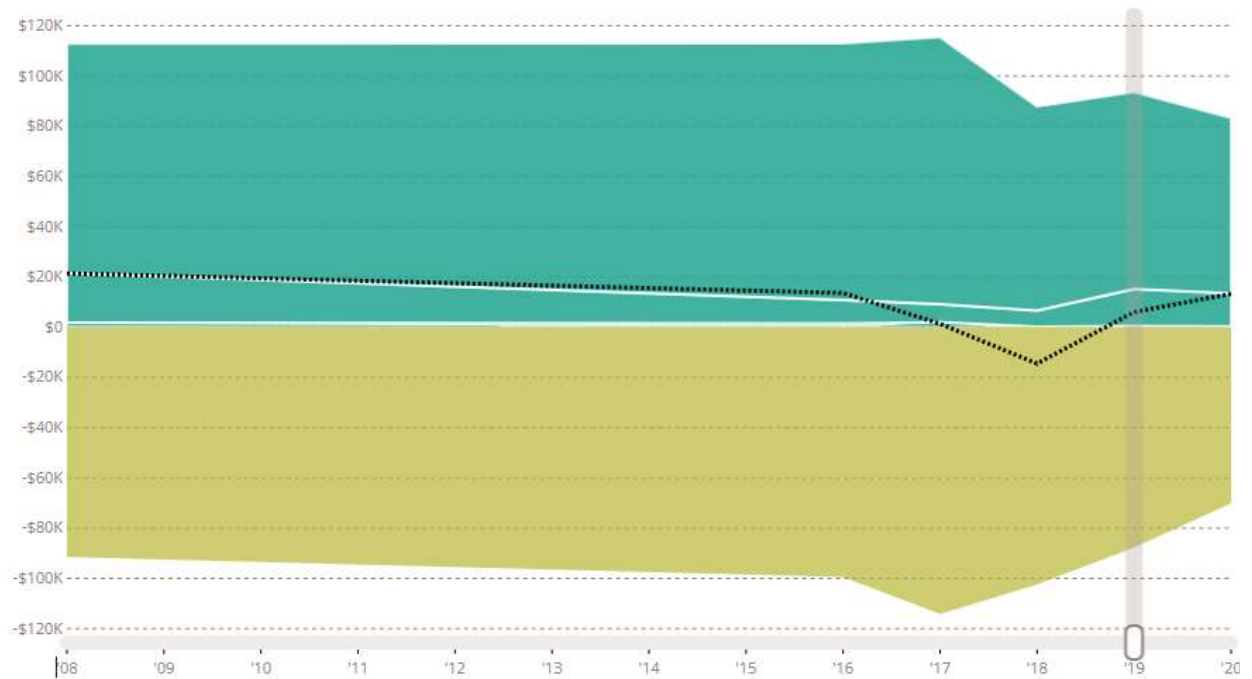

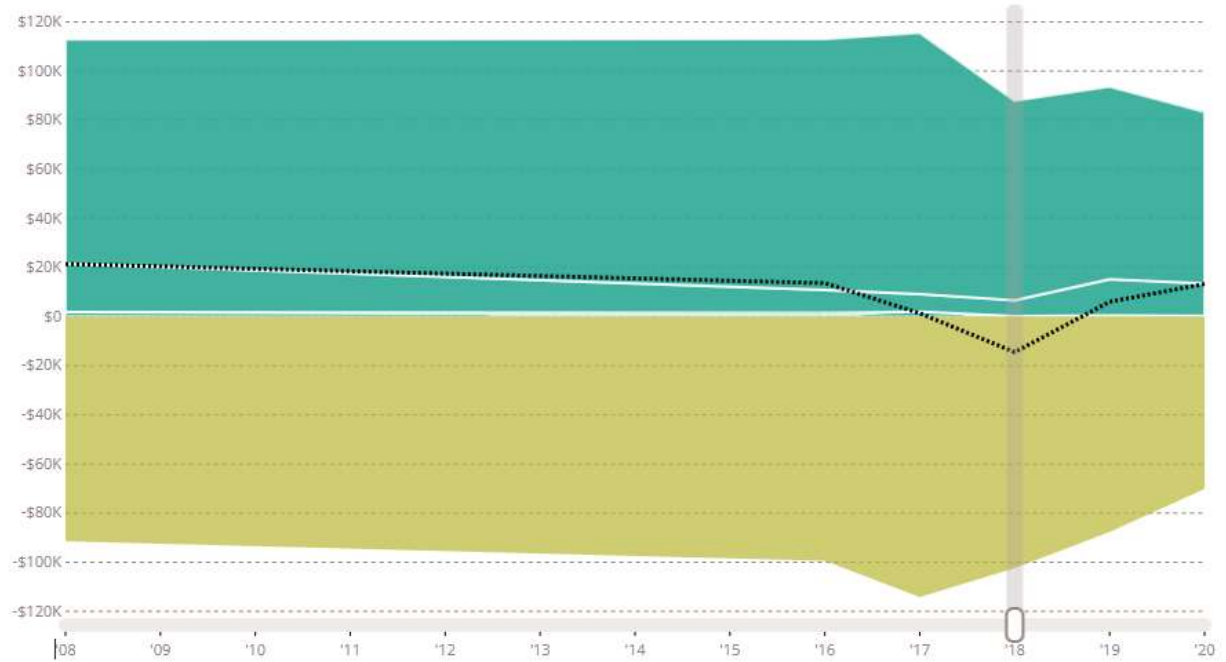

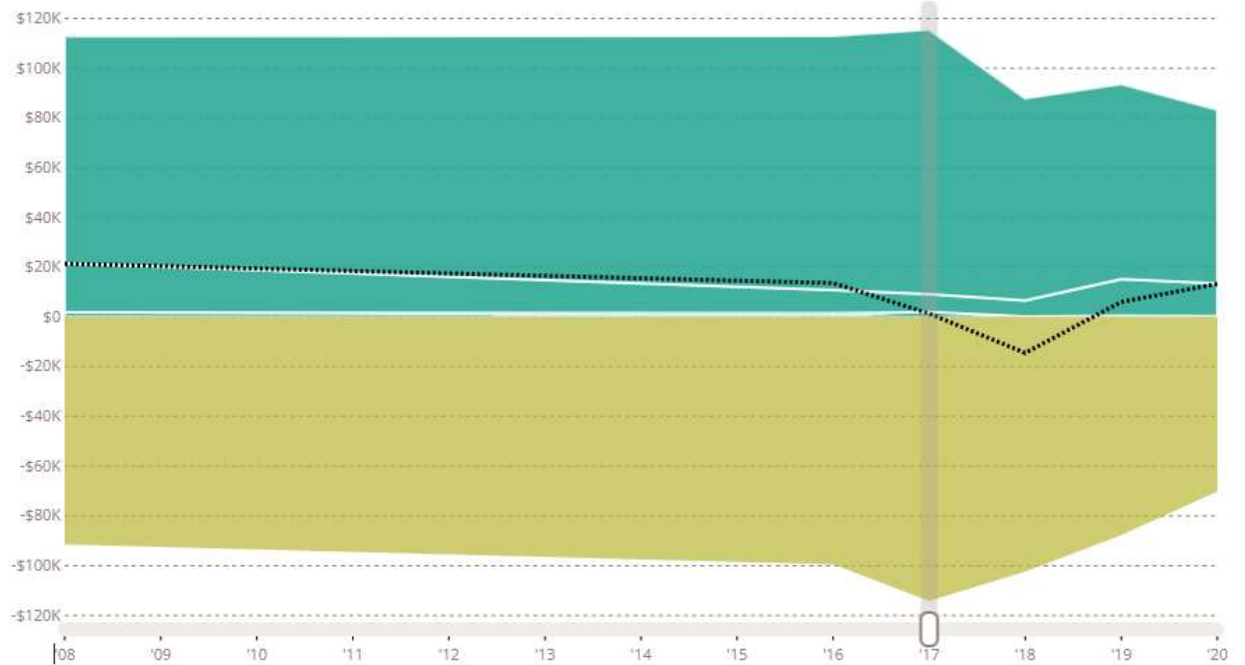

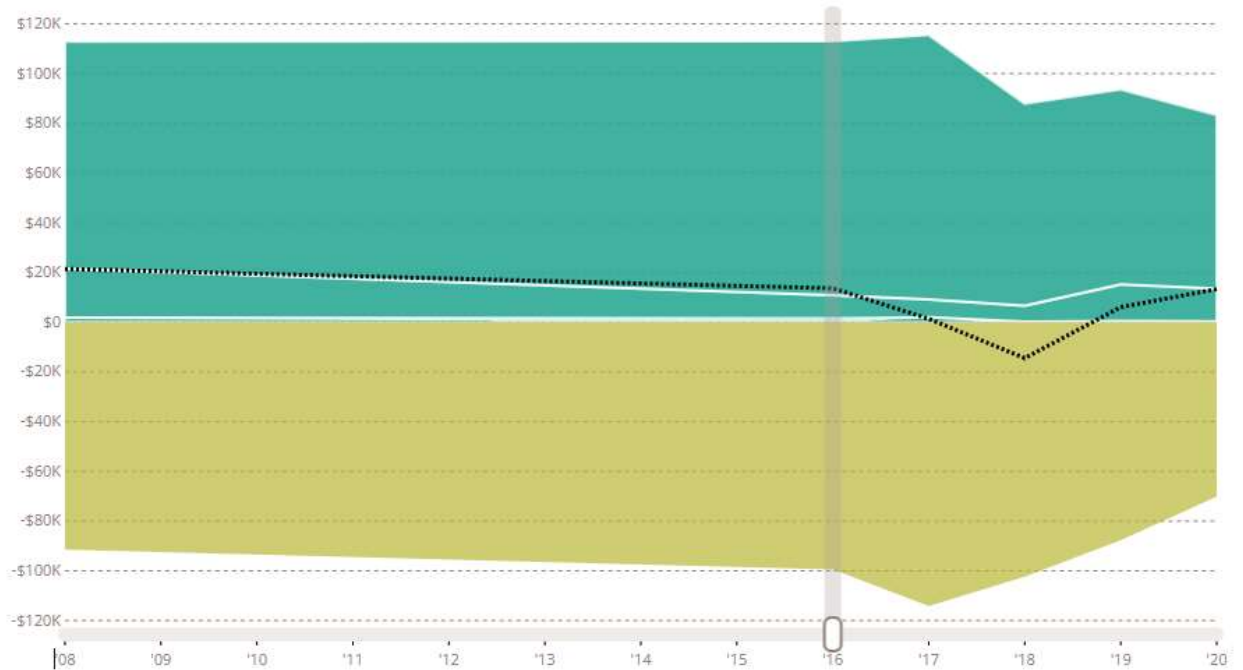

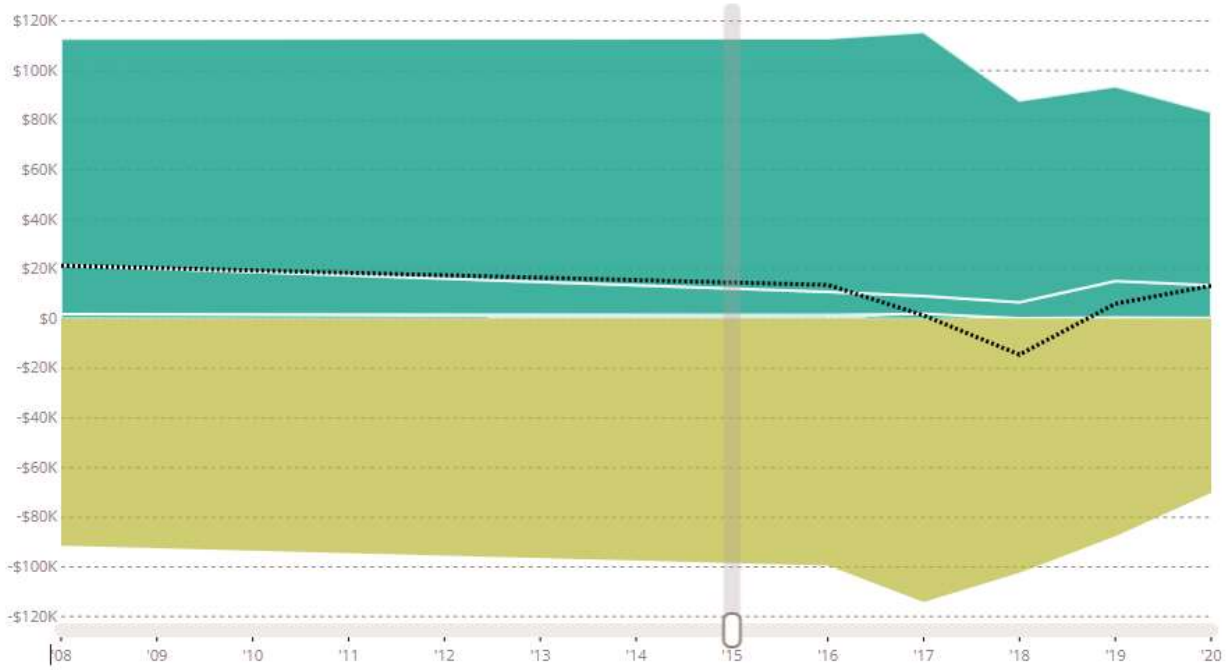

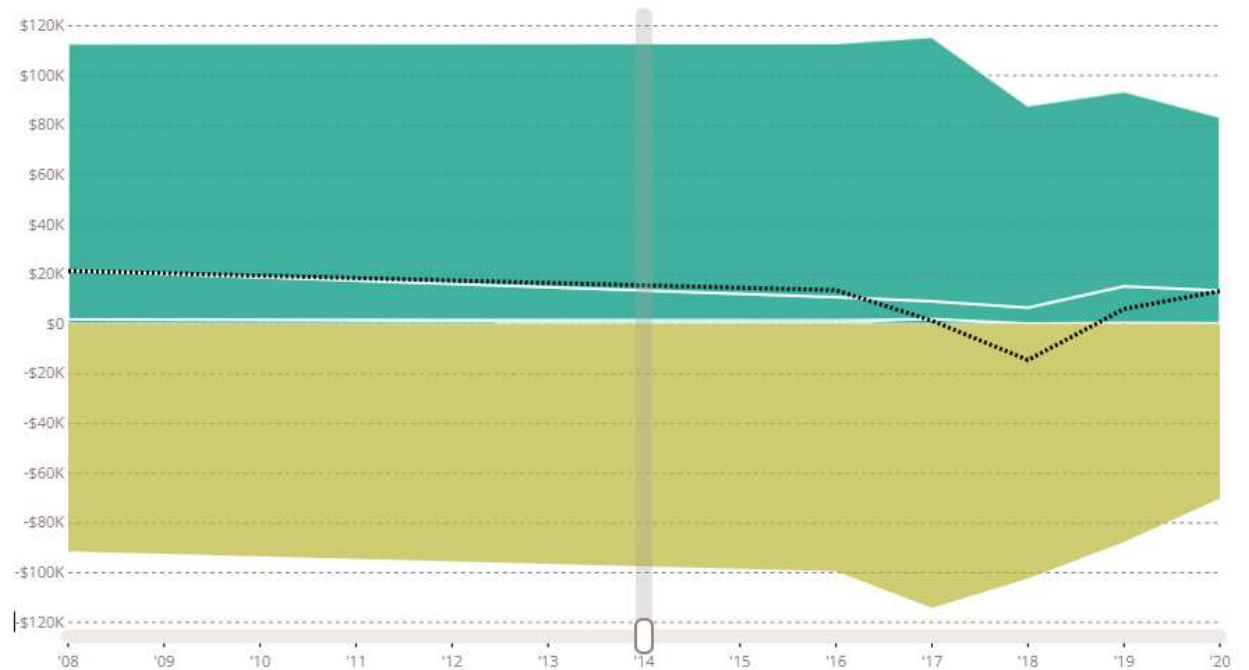
Revenue vs. expenses: 2014 breakdown

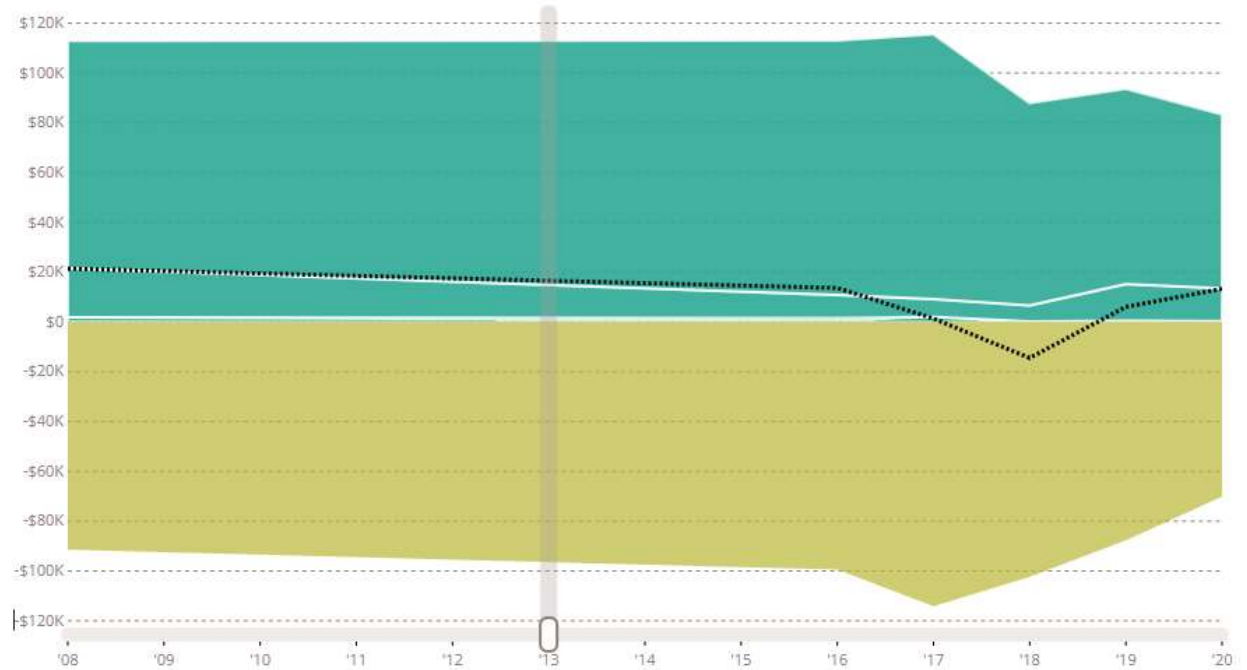

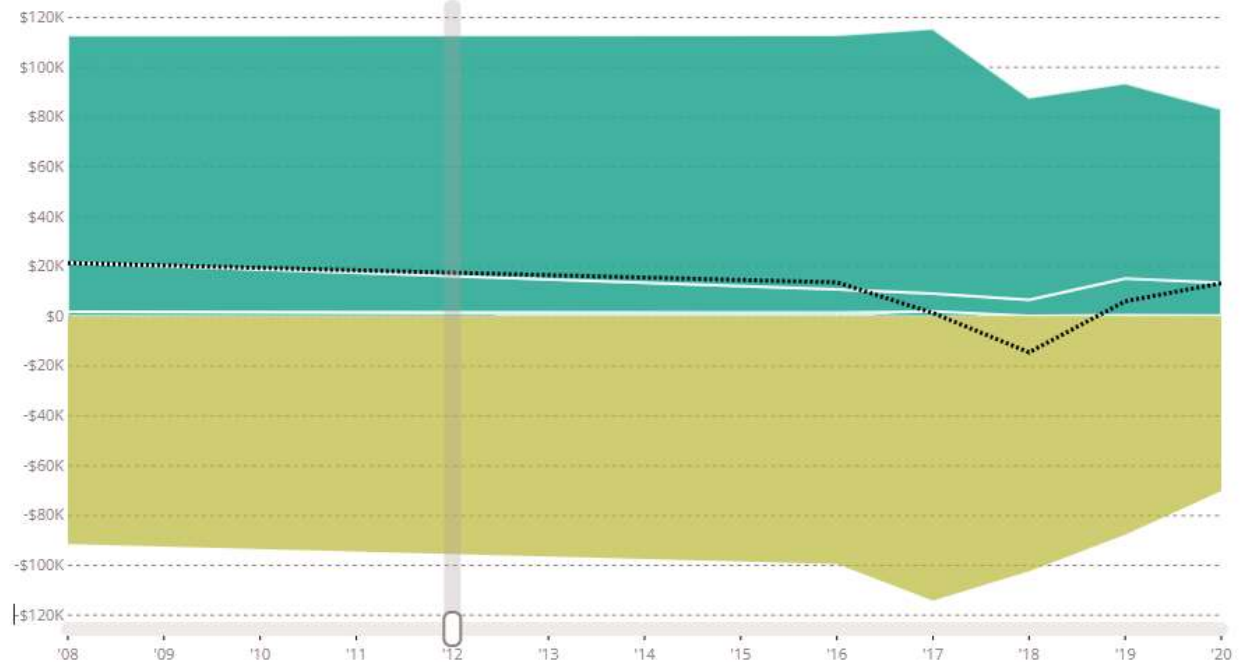

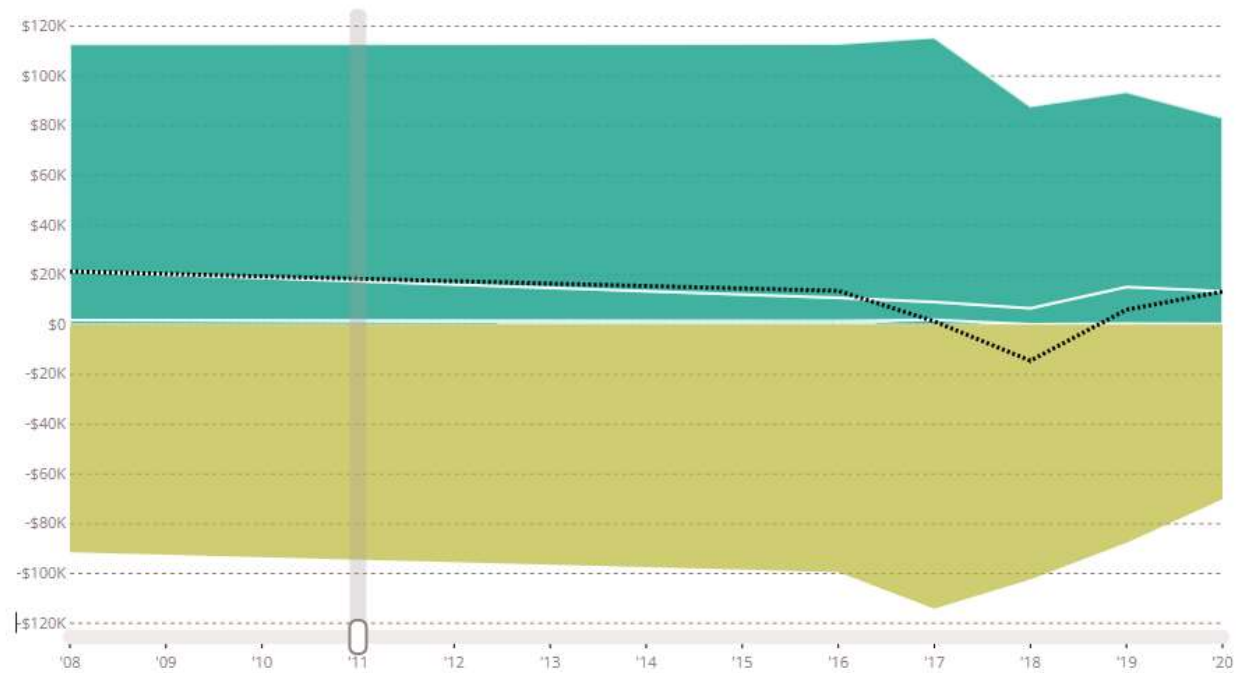

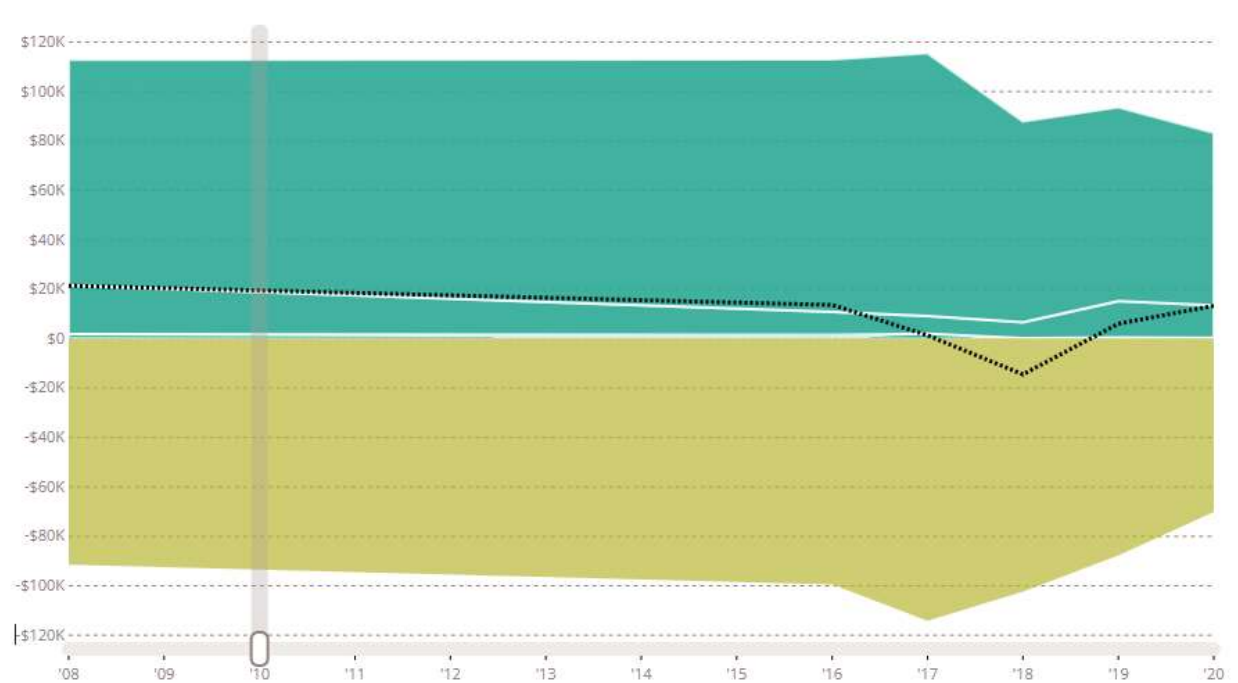

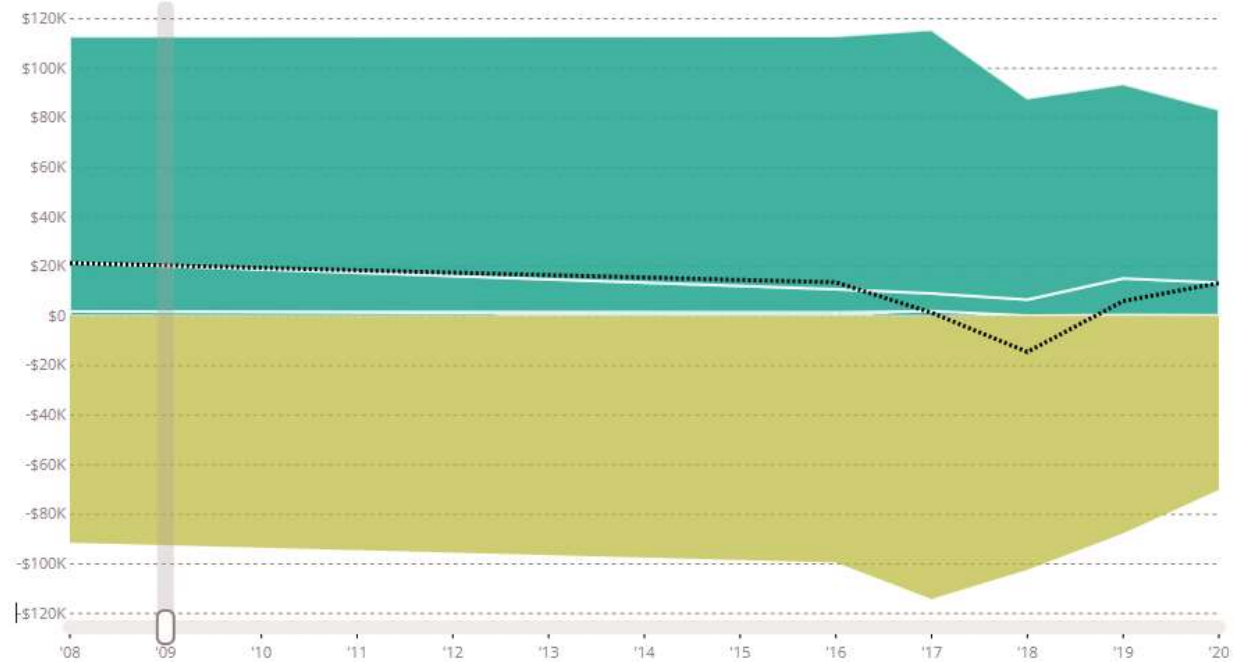

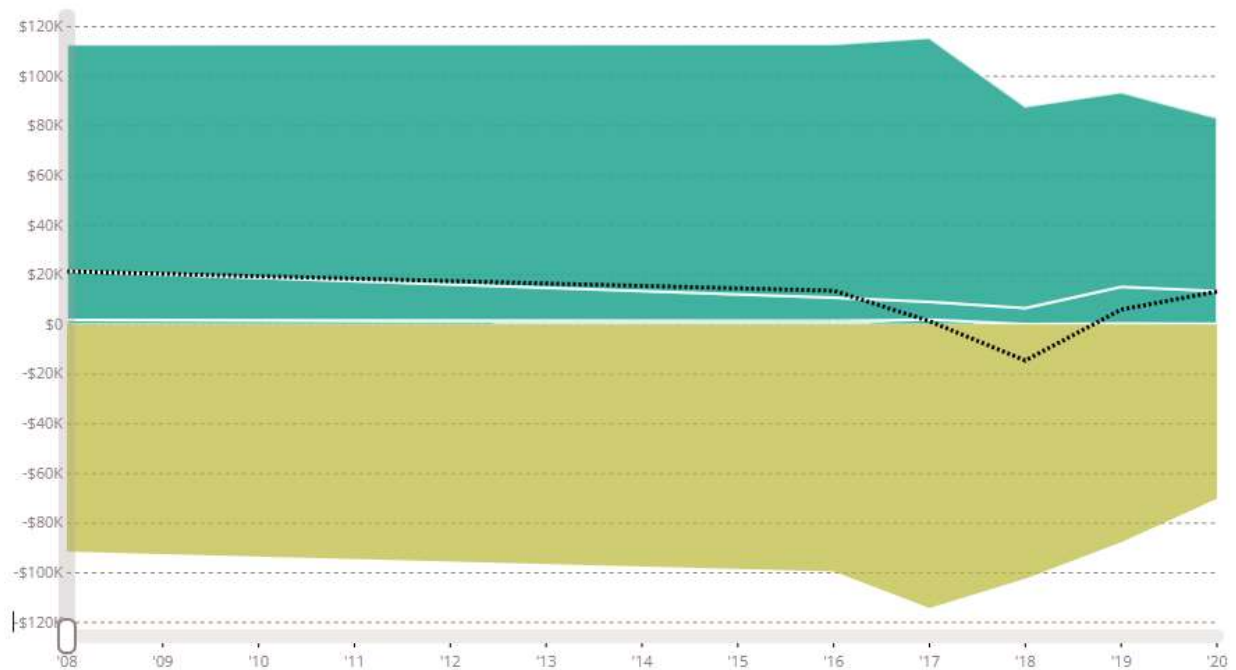
